

**Information for authors of scientific works in a Collection
“Information Technology and Security”**

Requirements for the electronic version of the article

Sheet size: A4 (21 × 29,7 cm).

Page setup (fields): 20 mm.

Text of the article: amount from 9 to 12 pages; font Times New Roman, 12 pt; typeface – direct; line spacing – single, indentation the first line of the paragraph – 1 cm; alignment – on the width.

ATTENTION! The last page of the article is filled in completely!

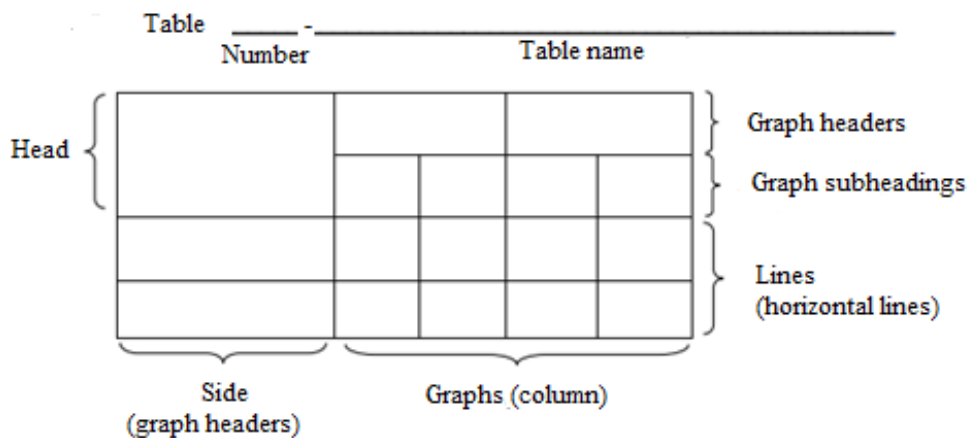


Figure 1 – Example of a table (according to DSTU 3008)

Illustrations should be placed directly after the text where they are mentioned for the first time or on the next page, in formats such as: tiff, jpg with a resolution of at least 300 dpi. All illustrations should be referenced in the text. Each illustration should have a caption that is placed under it for example: «Figure 1 – The layout of the placement». Illustrations can be separated from the text at the top and bottom by a single line. Axes on graphs should be indicated.

The table is placed directly after the text in which it is mentioned for the first time or on the next page and can be separated from the text at the top and bottom by a single line. All tables must be referenced in the text. Each table should have a title and number (see Fig. 1).

Set of formulas: Microsoft Equation Editor or MathType with parameters: regular – 12 pt, large – 16 pt, small – 10 pt, large index– 7 pt, small index– 5 pt. The style is mathematical. The serial numbers of the formula are specified at the level of the formula in parentheses at the far right on the line. Explanation of the symbols and the numerical coefficients in the formula, it is advisable to lead directly under the formula in the order in which they appear in the formula, for example:

$$Z = \frac{M_1 - M_2}{\sqrt{\sigma_1^2 + \sigma_2^2}} \quad (1)$$

where M_1, M_2 – mathematical expectation;

σ_1^2, σ_2^2 – standard deviation.

References follow the style of the Institute of Electrical and Electronics Engineers (IEEE style).

Structure of the article

1. **DOI** given in a separate line, on the left side, is defined by edition.
2. **UDC** given in a separate line, on the left side.
3. **Name and surname** (in large letters) of the Author (Authors) given by a separate line (separate lines), on the left side. Separated from UDC as a single line.
4. **Name of the scientific article** is given in large letters without indenting the first line of the paragraph with center alignment. Font – “Bold”. It is separated from the first and last name of the Author (Authors) by one line.
5. **Abstract** is given with a volume of 250 to 300 words (**at least 1800 characters, including keywords**), and separated by one line from its name. It includes a description of the main theme, object problems, objectives, and results of research. Also, the abstract indicates that this scientific article carries a new one compared to other similar topics and purposes.
6. **Keywords** are selected from the text of a scientific article of 5 to 8 words. Presented with a separate line from the paragraph after the abstract, denoting “**Keywords:**”. Each keyword is separated from the other by commas.
7. **Text of the scientific article** separated from keywords by one line and structured in the following elements:
 - problem statement in General view and its connection with important scientific or practical tasks;
 - analysis of recent researches and publications which initiated solving this problem and relied upon by, the allocation of unsolved aspects of the problem, which is the article dedicated to;
 - the article goals (problem);
 - the main material research with full justification of scientific results;
 - the findings from this study and prospects for further research in this direction.The text of the article is divided into appropriate sections with subheadings in bold.
8. **References** follow the style of the Institute of Electrical and Electronics Engineers (IEEE style). See an example: http://ela.kpi.ua/bitstream/123456789/16051/23/IEEE_style.PDF. Separated from the main text by one line. It is preceded by the words "List of references" without indenting the first line of the paragraph with center alignment.

The number of the Author / Authors works used in the list should not exceed 30%. However, it is advisable to refer to sources with DOI.

Among the works of the list of used literature, **there should be at least 50% references to the works of both domestic and foreign authors over the last 5 years.**
9. **Date of the scientific article receipt in the editorial board**, for example: “The article was received on 14.02.2020”. Separated from the list of references by a separate line left.
10. **Article Information in English** are separated from the date of the scientific article receipt in the editorial board by a separate line and submitted in the following order:

Name and surname of the Author (Authors) given by a separate line (separate lines), on the left side.

Name of the scientific article is given in large letters without indenting the first line of the paragraph with center alignment. Font – “Bold”.

Abstract with a volume of 250 to 300 words (**at least 1800 characters, including keywords**).

Keywords.
11. **Information about Author (Authors)** indicates surname, name, the middle name of the author (s), degree, academic rank, position, place of work, city, country, E-mail address. Separated from article information in English by one line.

The text of the article is divided into appropriate sections with subheadings

Subheadings appear in bold.
